Meta-data

The Georgia Society's 2018 Roster is the 2018 annual update of our 2017 Roster, reflecting new members approved in October 2017 and February 2018, resignations and deaths from May 2017 through April 2018, changes in membership category, and address changes. The 2017 Roster was compiled and revised in the following manner:

The Georgia Society's 2016 Roster was the basis for the 2017 Roster. It was revised to reflect changes incorporated in the 2016 General Society Blue Book proof compiled by Secretary Will Sheftall III in Fall 2016 from four sources – the General Society's member data base, the 2013 Blue Book, the Georgia Society's Directory Pages, and the Georgia Society's 2016 Roster with corrections annotated by Genealogist John Sheftall.

The 2016 Blue Book proof was finalized in consultation with Genealogist John Sheftall to verify the accuracy, wording and format of information on propositi and lineages, and submitted to the General Society on October 7, 2016 for publication.

In April 2017, the 2016 Georgia Society Roster was updated by Secretary Will Sheftall III to comport with the 2016 Blue Book entries. Georgia Society Genealogist John Sheftall then reviewed the information on each propositus of current members and compared it with the information published in the late Gordon Burns Smith's book on the Georgia Society, *Morningstars of Liberty*, and other genealogical materials pertinent to the Society he received from the late Gordon Burns Smith - his predecessor as Genealogist. Genealogist John Sheftall also performed independent research himself, in order to perfect the information on propositi.

Thus, as of May 1, 2017, the genealogical information in this roster supersedes in accuracy that published in the General Society's 2016 Blue Book, in instances where the information differs.

The accuracy of the Georgia Society's "Paid for Life" assessment membership was confirmed by Secretary Will Sheftall III in April 2017. The Georgia Society's 2016 Roster was used as the basis. It included the annotation "(P)" identifying members in this category. The assessment status of members thus identified was cross-checked by Executive Director Beth Owens against her records of those paying annual assessments – using records she received in 2016 from her predecessor, former Executive Director Donna Butler. Members with conflicting records were contacted by the Secretary, and their listing verified or rectified according to the member's own knowledge. Two members not annotated (P) on the 2016 Roster were confirmed and the (P) added. The listing for one member erroneously annotated (P) was corrected.
